About Law Access

Law Access aims to improve access to justice for the most disadvantaged and marginalised people in Western Australia. We assist some of the most vulnerable people in WA, who would otherwise be unable to obtain legal assistance. We receive requests for assistance from all over the State, and in all areas of the law, and match those who will most benefit from legal assistance, with lawyers willing to provide pro bono assistance.

Our Law Access Pro Bono Gateway delivers:

- Referrals to Western Australian pro bono lawyers
- · Referrals to the legal assistance sector
- Research, policy and law reform to address unmet legal need in Western Australia
- Support and resources for pro bono culture to thrive in Western Australia
- Volunteering opportunities for law students and PLT graduates

Law Access is a company limited by guarantee and a public benevolent institution registered with the Australian Charities and Not For Profits Commission. Law Access Limited was established by The Law Society of Western Australia in December 2014 to implement the recommendations of a Lotterywest funded feasibility study Doing The Public Good by Kalico Consulting. Law Access Limited commenced delivering the Law Access Pro Bono Referral

Chairman's Foreword

Just over 5 years ago, Law Access was established by the Law Society of WA, with the ambitious objective of delivering a state-wide service to relieve the disadvantage suffered by those in our community who merit but are unable to get legal assistance. Its aim was to achieve that important objective by arranging for members of the WA legal profession to provide their services either pro bono, or at a reduced rate, or on a deferred fee basis.

In the following five years of its operation, Law Access has advanced the important cause of access to justice for those with insufficient means to obtain legal assistance and who do not meet the criteria of Legal Aid WA. In those 5 years, it has:

- responded to 3271 first enquiries, to provide helpful information;
- received and processed 2562 applications for pro bono assistance;
- made 895 referrals to lawyers to provide free, reduced or deferred fee legal assistance, as appropriate;
- explained to 1281 applicants why their matters were not suitable for referral for pro bono legal assistance:
- supervised and trained 120 law student volunteers and interns; and
- given Practical Legal Training to 5 volunteer graduates.

The past year was one of innovation and growth, as well as unforeseen and unforeseeable challenge for Law Access.

A new Law Access website was launched, enabling online applications to be made, and featuring an online portal so that pro bono lawyers may express their interest in potential referrals. I have no doubt that this will result in increased efficiencies, and greater service to the public.

The first of what is planned to be a series of Law Access Impact Reports was launched by the Hon. Justice Jennifer Smith (a great supporter of Law Access since its inception) at a function generously hosted by MinterEllison on 1 December 2019. It is hoped that such Impact Reports will cause more people to appreciate the value which Law Access provides, and the vital role it plays in the pursuit of justice for all; and that this may in turn prompt private and institutional donors to fund, or continue to fund, Law Access, as well as encourage even more members of the legal profession to provide pro bono legal assistance.

In late May 2020 Law Access entered into an MOU with Community Legal Western Australia to help implement the new WA Pro Bono Model, with much appreciated funding support from the WA Government. Law Access and Community Legal WA will build on, and improve, the referral pathway from Community Legal Centres to law firms willing to provide pro bono assistance.

Those are some of the innovations of the year. The challenge, in the second half of the year, was how to address the unprecedented problems resulting from the COVID-19 pandemic. Law Access did so in a measured and responsible manner, providing its services by telephone and other electronic means, whilst observing "social distancing". An annual event, to raise funds, has been the Walk for Justice. Would the restrictions imposed by the pandemic mean its cancellation? No, Law Access instead delivered a virtual "Walk for Justice". Held on 19 May 2020, it turned out to be the most successful Walk for Justice so far. Participants

joined in, by electronic means, from locations as far afield as Port Hedland and Sydney. Almost \$100,000 was raised in donations.

Law Access farewelled, with gratitude for their service, a number of staff members this year: Principal Lawyer Michele Lord, Senior Family Lawyer Linda Cao, Project Officer Emiko Watanabe and Legal Secretary Richa Malaviya. It also welcomed new team members, including Tina Price and Lisa Jarvis, who jointly filled a new full-time Principal Lawyer role.

Those who work for Law Access, headed by its capable and devoted CEO, Dominique Hansen, are a special breed, strongly motivated by the creed of "justice for all", and able to cope with the daily pressures and stress that inevitably arise when dealing with people who firmly believe they have suffered injustice, and sometimes have to be told that no remedy is available to them.

I sincerely thank, on behalf of the Board, the dedicated staff, past and present of Law Access, and the volunteers and law firm secondees who assist them to co-ordinate the provision of pro bono legal assistance in Western Australia.

Nor could Law Access provide the essential service it does, but for the generosity of pro bono lawyers, donors (both in cash and in kind) supporters, stakeholders, sponsors and funders. To all of them, we and the community owe a debt of gratitude.



Comparison Applicant Profile ▼



Family Law

Lien* experienced family violence in her marriage and was unemployed. Following her divorce, she obtained Family Court Orders that her ex-husband pay her a small financial settlement. He was in significant arrears having paid only a tiny portion of what she was due. A Pro Bono Lawyer assisted Lien to enforce the Court Order, ensuring her ex husband paid her what he owed her. The small financial settlement made a big difference to her life.

Lien told us the best thing about having a probono lawyer was:

"[They gave] me trust that what I was doing was the right thing to do and [showed] my ex-husband that he can't get away with everything because he thought no one would help me... My ex-husband would have got away with ignoring court orders as there was no way I could afford further legal action".

Guardianship and Administration

John* has a disability and applied to Law Access for assistance with a guardianship matter. John described the help he received below:

"[My Pro bono Lawyer] collected all relevant reports and tests, explained legal processes clearly and fully, kept me informed all the way, acted in my best interests. I would never have succeeded without a very competent, experienced lawyer familiar with Civil Law cases."

In his feedback survey John explained to Law Access that the pro bono referral had made a positive difference to his life by enabling him to move into "supported share accommodation in a nice modern house".

Positive feedback provided by a not-for-profit organisation to their pro bono lawyers

"On behalf of the [De-identified Organisation*] Board and staff, thank you so much for the last 12 months of support, legal advice and guidance as the organisation struggled to address its constitution and grievance complaint.

Your pro bono assistance was so valuable throughout this time and went well beyond the level of our initial request".

Law Access underwent significant changes this year. We farewelled a number of members of our team during the course of the year but also created and filled three full-time positions, having always previously operated with part-time roles.

Key milestones achieved included:

- Launching our new website lawaccess.org.au and our first Impact Report on 1 December 2019
- Transitioning to electronic only files in March 2020;
- Holding our first virtual Walk for Justice in May 2020;
- Concluding an MOU with Community Legal WA and a grant agreement with the Department of Justice to help implement the new WA pro Bono model from 1 July 2020;
- Achieving the key actions set out in our first strategic plan and developing a new plan from 1 July 2020.

Enhancing Our Services

This year we received a record 552 applications for pro bono assistance and referred 216 matters to lawyers including 37 applicants who were had fallen through the gaps and were warm referred to funded legal assistance services such as Community Legal Centres and Legal Aid.

The launch of our new website in December 2019 made it easier for pro bono lawyers to express interest in our referrals and importantly made it easier for service providers such as Community Legal Centres to complete online "warm referrals" to Law Access.

The new website also includes an online application form for individuals and in the first quarter of 2020 the numbers of applications directly from individuals peaked, creating a backlog in processing for the service. We responded by maintaining "warm referrals" from service providers but suspending new applications from individuals for six weeks while we caught up with the backlog. We also made changes to our online form for individuals which ensured applications submitted were complete and which emphasized the service's eligibility requirements, including assessment of means and prospects of success.

Working in partnership

Law Access is a team effort. This year Law Access worked with the following committees and groups:

The Law Access Stakeholder Advisory Committee met three times to help guide the work of Law Access.

Sponsored by Allen's, the Law Access Pro Bono Co-ordinators' Committee, comprised of representatives from large and medium sized law firms, met four times this year.

Law Access participated in the Collaborative Services Planning Group created under the National Legal Assistance Partnership Agreement.

Law Access raised policy and advocacy issues, including the age of criminal responsibility and lawyer access to prisoners and detainees, through the Law Society's Access to Justice Committee.

Our Senior Civil and Migration Lawyer made referrals to our dedicated Law Access Lawyers for Refugees Network. Jessica also took part in related national working groups and sent regular emails to Network members keeping them up to date with developments.

Law Access promoted our pro bono referrals through the Law Society of Western Australia, the Family Law Practitioners' Association of Western Australia and the Criminal Lawyers' Association of Western Australia.

Law Access participated in the Protection and Care Advocacy Network and joined the Alliance of Practitioners in Protection and Care.

Law Access staff delivered presentations at a variety of public fora to explain what we do and to promote pro bono work.

Building Organisational Capacity

This year we farewelled Principal Lawyer Michele Lord, Senior Family Lawyer Linda Cao, Project Officer Emiko Watanabe and our former Practical Legal Training volunteer and first Legal Secretary Richa Malaviya. I would like to take this opportunity to thank these hardworking team members for their contribution our success. Although the staff turnover we experienced was challenging, we were fortunate to welcome Tina Price and Lisa Jarvis in a full-time job-share Principal Lawyer role, while Jessica Bayley accepted a

full time Senior Civil and Migration Lawyer role. Claudia Hall joined the team as full-time legal secretary in Late February and former student volunteer Aleisha Sleight took up a part time project officer role focusing on communications in late May.

Law Access continued to receive extensive in-kind support from The University of Western Australia and The Law Society of Western Australia.

Filepro continued to donate their electronic file management software and support to Law Access. This enabled a smooth transition to remote working arrangements.

Law Access also continued to receive donated archival and storage services from Compu-Stor, a vital service which has provided in kind support since our first year of operation.

per week throughout the year. This
has significantly enhanced our
service effectiveness.

We are grateful to King & Wood Mallesons for continuing to second lawyers each fortnight to undertake Judicial Review work with our Senior Civil and Migration Lawyer.

We are also grateful for pro

bono lawyers Michael Cashman, Genevieve French, Lisa Jarvis and Hilary Kumbirai Kavumbura, who volunteered at Law Access to assist with triage and referrals.

We received in kind paralegal and administrative support from law student volunteers and student interns from The University of Western Australia, Edith Cowan University and the University of Notre Dame Australia, Murdoch University and Curtin University.

Ensuring our sustainability

A focus on increasing our social media engagement was essential to the success of our virtual Law Access Walk for Justice. Our sponsors, Event Ambassadors and generous donors, including the McCusker Charitable Foundation, ensured this year's event reached the most supporters and raised the most funds to date.





Figure 2 below shows Law Access Expenses for 2019-20:
