PRO BONO LAWYERS STEP IN TO HELP THE MOST VULNERABLE

At 7:30am on National Pro Bono Day, 18 May 2021 the Hon. Peter Quinlan, Chief Justice of Western Australia launched and lead the 2021 Law Access Walk for Justice. Hundreds of pro bono lawyers from community legal centres government and the private profession, law students and legal support, gathered to promote Equal Access to Justice in Western Australia.

The walkers followed the traditional foreshore route, between Point Fraser and the Bell Tower. They were "virtually" accompanied by supporters from around Australia including Albany, Karijini National Park, Sydney, Melbourne and Bundaberg.

The beginning of the walk was livestreamed on Facebook. The 'virtual' supporters were invited to tune in to the 2021 event podcast, while completing the 4.4 kilometre walk wherever they may be - one team will be walking in the Karijini National Park!
